Balance Sheet Cash At the start of the new fiscal year cash on hand was \$138096. Guaranteed Investment ELMHA currently holds \$96050.00 in GIC's. Capital Assets Computers, shirts etc is currently at \$342.00 Accounts Payable \$2500 at time of balance sheet Statement of Operations Total Revenue is \$200570. Total Revenue is \$2238084. Net Assets at the end of the year were \$180967. Paula mentioned there is deficiency of \$14000. Paul Moffatt spoke regarding the deficiency. Registration was later last season and the year end was May 31<sup>st</sup>. Registration was raised this past season by 8% which is \$35 per player.
