#### Shamrock

- Voted at meeting to implement the "2 GM" rule for midget age players in league playoffs only

If a player gets 2 game misconduct penalties anytime in league playoffs they are eliminated for the remainder of the season. This is to help curtail excessive, aggressive behaviour. Wording to follow from Todd (Shamrock President)

The Shamrock league has engaged in many conversations over the years, involving all centres, around the need to implement a policy to assist with deterring unsportsmanlike play as the season winds down. (Ie fighting)

As such a motion was passed at our last meeting to ratify into our policy the following:

In effect immediately MAJOR PENALTY RULE

Each player is "allowed" one Major Penalty (GM) during the entire Shamrock League Playoffs. A player being assessed their second Major Penalty is disqualified from further participation in the Shamrock League Playoffs for the remainder of the season, and is considered to be an ineligible player.

Please note that OMHA policy referencing suspensions for such infractions will apply to carry-overs into the following season.

Please ensure your players know that 2GMs (in Shamrock) means their season (in Shamrock) is done. Period. No disputing, no appeal.

This same rule was implemented in the Bluewater league with significant success. It's our hope that the Shamrock league experiences the same.
